IRAC reclassified fiberglass wool as Group 3 (not classifiable as to its carcinogenicity to humans) based on current human and animal research that shows no association between inhalation exposure and development of respiratory disease. ACGIH (A3 – Confirmed animal carcinogen with unknown relevance to humans) and NTP (Reasonably anticipated to be a carcinogen – respirable size) have not reviewed the IRAC reclassification of fiberglass wool and continue to base their classifications on earlier animal studies.
